In pursuance to the recommendation of the Departmental Assessment Committee (DAC) of MoEF&CC for *in situ* promotion to the next higher grade under Flexible Complementary Scheme (FCS) as on 01.01.2023, the following Group-‘A’ scientists of BSI are *in situ* promoted w.e.f. 22nd October, 2023 i.e. the actual date of approval of the Appointing Authority in officiating capacity to the post with pay scale and pay level of the pay matrix as recommended by the said DAC shown against each of them :

It is also kept in record that said DAC did not recommend *in situ* promotion of Dr. O. N. Maurya, Scientist –D, BSI-CRC-Allahabad under Rule 12(5) who will be undergone for considering normal residency period due as on 1st January, 2024.

Consequent upon their *in situ* promotion to the next higher grade under FCS as indicated above, eight temporary posts of Scientist-'D' in the pay scale of Pay Scale : Rs.78,800/- to Rs.2,09,200/- (Level-12) have been CREATED w.e.f. 22nd October, 2023 to affect the said promotion and simultaneously eight posts of Scientists-'C' stand ABOLISHED with effect from that date. The up-gradation of the post is purely personal to the incumbent and causes no further vacancy on account of the said up-gradation in the levels as shown above. The overall strength of Scientists in BSI, taking all grades together remains unaltered. The posting of all *in situ* promoted scientists will remain unaltered and unchanged.

The Pay of the above-mentioned scientists shall be fixed w.e.f. 22.10.2023 i.e. the date of approval of the Appointing Authority.
